## MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Change 1, Implementation Guidance for Stabilization for Active Component (AC), Individual Mobilization Augmentee (IMA), and Individual Ready Reserve (IRR) to Reserve Component Transitions - Mobilization Deferments

## 1. References:

- a. Headquarters (HQ), U.S. Army Reserve Command (USARC), AFRC-PRM (601-210) memorandum (Implementation Guidance for Stabilization for Active Component (AC), Individual Mobilization Augmentee (IMA) and Individual Ready Reserve (IRR) to Reserve Component Transitions- Mobilization Deferments), 31 August 2021.
- b. Army Regulation (AR) 135-91, (Service Obligations, Methods of Fulfillment, Participation Requirements, and Enforcement Procedures), 14 March 2016.
- c. AR 601-210, (Regular Army and Reserve Components Enlistment Program), 31 August 2016.
  - d. AR 601-280, (Army Retention Program), 16 June 2021.
- 2. This memorandum supersedes reference 1a. The purpose of this memorandum is to offer a stabilization period for involuntary mobilizations up to 36 months and provide implementation guidance concerning deferment from involuntary mobilization for Soldiers who meet the following eligibility criteria:
- a. AC Soldiers who transfer directly into a Troop Program Unit (TPU) are authorized 36 months of stabilization from the date of assignment.
- b. Soldiers (IMA or IRR) who deployed within 12 months prior to transferring into a TPU will be authorized a 24-month mobilization stabilization from the date of assignment.
- c. Soldiers (IMA or IRR) who deployed between 13 and 24 months prior to transferring into a TPU will be authorized an 18-month mobilization stabilization from the date of assignment.

- d. This policy does not apply to TPU Soldiers reenlisting for another term in the USAR.
- 3. IRR Soldiers who transfer will include the following statement on their DA Form 4187, "A mobilization stabilization applies to this transfer; see attached Army Reserve Deployment Stabilization Statement." Attach the completed Mobilization Stabilization Statement to the DA Form 4187.
- 4. For AC Soldiers, the Reserve Component Career Counselor (RCCC) will add the Mobilization Stabilization Statement to the DA Form 3540 as an addendum.
- 5. Gaining units will annotate the Soldier's Personnel Maintenance Module of Regional Level Application Software (RLAS) with a Movement Non-Availability Reason (MVNAR) code of "SD" for the appropriate time period (18, 24, or 36 months). The source document to determine eligibility is the Mobilization Stabilization Statement.
- 6. The accessioning agency is responsible for uploading the Mobilization Stabilization Statement to the Soldier's Interactive Personnel Electronic Records Management System (iPerms) profile and confirming the upload was successful.
- 7. This policy is only a statement of the USAR's intent not to mobilize a Soldier during their stabilization period. Under extreme circumstances, mission requirements may dictate whether Soldiers are involuntarily mobilized subject to this policy during their stabilization period. The Deputy Chief of the Army Reserve is the authority to waive the stabilization period. Any delegation of waiver authority must be in writing and cannot be delegated below the first General Officer in the Soldier's chain of command.
- 8. This policy does not guarantee a Soldier will remain in the same unit for the stabilization period.
- 9. Soldiers enlisting into a unit with a priority code 10 in the REQUEST System, viewed through the Automated Vacancy Entry (AVE) System, are ineligible for Mobilization Deferment. The accessioning agency is responsible for informing Soldiers of their ineligibility for a Mobilization Deferment.
- 10. Soldiers may voluntarily waive the stabilization period for deployment or mobilization by completing the "Reserve Component Soldier Waiver of Individual Dwell and Notification for Mobilization under an Involuntary Authorization" form. The stabilization period granted by this policy will not be reinstated upon a Soldiers return from a

voluntary mobilization or deployment.

- 11. Applicants may be eligible for other incentives in effect simultaneously.
