SUBJECT: Delegation of Authority #22-02: Army Reserve Troop Program Unit (TPU) Deferral of Separation due to Mandatory Removal Date (MRD) Recommendations

- 2. Effective immediately, I delegate authority to make recommendations to the Assistant Secretary of the Army (Manpower and Reserve Affairs) on TPU officer deferrals of separation due to MRD as follows:
- a. In those cases where the USARC G-1 is not in agreement with the Major Subordinate Command (MSC) commander and the action does not meet the criteria for disapproval established in reference 5, the Deputy Commanding General, USARC.
- b. In those cases where the USARC G-1 is in agreement with the MSC commander and the action does not meet the criteria for disapproval established in reference 5, the USARC Deputy Chief of Staff, G-1, which may be further delegated to Chief, Military Personnel Division.
- 3. This delegation remains in effect until superseded, rescinded, or withdrawn.
