a. I have not received an initial uniform allowance in excess of \$400 during my current tour of active duty or within a 2-year period before beginning this tour of duty.

b. During the 2-year period prior to reporting for my current tour of duty, I have not served on active duty or ADT for a period of more than 90 days as a non-regular officer.

Block 1. Enter unit address to include Personnel Accounting Symbol (PAS).

Blocks 2 and 3. Enter name and SSN as shown on the Master Military Pay Account (MMPA).

Block 4. Self-explanatory.

Block 5, items a - d. Mark the appropriate box that identifies how the officer became entitled to an Initial Uniform Allowance.
