SUBJECT: Extension of Temporary Change to Timeline for Requesting Voluntary Retirement from Active Service

1. References:

- a. Army Regulation 600-8-24 (Officer Transfers and Discharges).
- b. Army Regulation 635-200 (Active Duty Enlisted Administrative Separations).
- c. Amendment to Temporary Change to Timeline for Requesting Voluntary Retirement from Active Service (18 April 2023).
- 2. In order to improve Soldier management and retirement planning, I hereby approve an extension to the temporary change to the timeline for Soldiers requesting voluntary retirement from active federal service. This extension will expire on 31 March 2025, unless the exception is made permanent.
- 3. Soldiers will submit voluntary retirement requests at least 12 months, but no more than 24 months, before their retirement date. Soldiers requesting voluntary retirement must have 18 or more years active federal service and be able to complete all service obligations by the requested retirement date.
- 4. A Soldier who has requested voluntary retirement will not be given orders for an involuntary permanent change of station (PCS). Soldiers with 18 to 19 ½ years of active federal service who are notified of a PCS may request retirement in lieu of the PCS within 30 days of the notification. The requested retirement date must not exceed 20 years of active federal service. Policy for requesting retirement in lieu of PCS remains otherwise unchanged.
